### Terms & Conditions

#### Stayz/HomeAway/Airbnb:

Credit card (Mastercard & Visa only) details are required for all instant bookings. If less than 28 days to arrival, the full amount is debited.

**\*Fires:** Wood fires are not permitted on site. Both houses provide inside heating with an internal gas fireplace and reverse cycle air-conditioning. All internal chimneys have been capped and are too brittle to cope with the heat generated by fires (with the exclusion of the professionally fitted gas fire supplied).

**\*Losses & Breakages:** Excluding normal wear and tear, any losses and breakages will be reclaimed on the booking applicant's nominated credit card. Full responsibility lies with the booking applicant. Stay on the Park prides itself in the superior quality of its accommodation. - It is necessary for us to collect Personal Information to carry out a number of functions, including but not limited to;

E-mails transmitted from the hosting server to the Stay on the Park reservations service are protected using a 512 character key utilising cipher text encryption to prevent and detect tampering with, interception, or forgery of messages.

#### Secure channels:
